At Baker Bobby's Pizzaiolo LLC we strive to use the freshest ingredients available including local organic and/or farm-to-table fruits and vegetables. We are committed to making your event a success and we work closely with our customers to create an unforgettable experience. We accommodate small or large events whether it be a casual party or an extravagant wedding. Please read through our enclosed contract and if you have any questions do not hesitate to call or email.

Payments & fees, etc.

- There is a 50% retainer fee to secure your event date unless prior arrangements have been made. We accept cash, checks, or credit cards (w/fee). Checks should be made out to Baker Bobby Pizzaiolo LLC and mailed to PO Box 1657, Ogunquit, ME 03907.
- In case of inclement weather, we will weigh out our options with you before we leave our home. If we determine the weather unsafe to serve or travel, your deposit is 100% refundable. We will certainly see if we are able to work out an alternate plan for your event.
- All applicable state or local taxes must be paid by the client unless the client's organization is tax-exempt in which case Baker Bobby must receive a certificate reflecting the exemption status. If it is not received within five working days of the event the client will need to pay the taxes.
- If we need extra service staff, additional food, or soft drinks due to more guests attending, both parties will need to agree on these further charges that are above our quoted price. These changes must be made at least 10 days prior to the function and such final guarantee, whether written or oral shall be binding, and in no way shall the guarantee be less than the originally agreed fee.
- Food and beverages will be served between the agreed time frame and for the event to run smoothly we may need 1 to 2 hours before & after the event for set-up and clean-up.
- If the event is canceled within one month of the date Baker Bobby Pizzaiolo LLC can retain 50% of the retainer fee as liquidated damages or miscellaneous expenses.
- Gratuity is at your discretion but the recommended amount is 15%.
- A final invoice will be provided 7 days before the event listing all costs and any fees in connection with this event (less deposit or any other payments received). Balance due is paid in full on the day of the function with cash, check, or credit card(w/fee).
- There is an additional fee of \$150.00 per server. We endeavor to make your event memorable therefore servers are added as we feel necessary.
- There is an additional fee for travel with a hot oven. Price is dependent on distance, which is agreed upon by both parties. (*minimum \$150.00 - \$300.00*)
